### **EXECUTIVE SUMMARY:**

A notice was mailed to all current solid waste (garbage, Clean Green, recycling, Clean-Up Campaign, and household hazardous waste) customers on April 9, 2010. The notice informed solid waste customers that a Public Hearing was set for May 25 regarding proposed increases to solid waste rate charges and summarized the proposed rate increases. The notice was mailed out more than 45 days prior to the May 25 scheduled Public Hearing, as required by Article XIII D of the California Constitution.

At the Council meeting, Council will need to open the Public Hearing and hear protests regarding the proposed rates. In addition, the Council meeting will be the last opportunity for City solid waste customers to return written protests against the proposed rates. At the close of the Public Hearing, the protests will be tabulated. If a majority of solid waste customers protest the proposed rates, Council will be unable to raise the solid waste rates. If there is not a majority protest of the rates, Council may increase the solid waste rates as specified in Table A of the Resolution.

Agreements are in place with Mission Trail Waste Systems (MTWS) for collection of solid waste in the exclusive franchise area, with Recology Santa Clara to provide residential single-stream recycling, and with IDC/Newby Island Landfill to provide solid waste disposal and composting services. Each agreement contains cost-of-living adjustment formulae, which adjust the rate of compensation paid to the service providers on an annual basis. Adjustments to service provider rates of compensation are then incorporated into customer rates in an effort to fully recover the cost of services. The proposed shift in rates for garbage, Clean Green, and recycling services for FY 2010-11 are higher than the typical cost-of-living formulae because new agreements with enhanced services have created new baseline levels of compensation for the service providers.

In accordance with its exclusive franchise agreement that was approved by Council on December 15, 2009, MTWS will receive a 2.0% increase to its Schedule of Tariffs on July 1, 2010, followed by a 7.9% increase on January 1, 2011, assuming it has placed all of its new CNG fuel residential collection vehicles in service by that date. Recology Santa Clara implemented the new residential single-stream recycling program on December 7, 2009 and received a mid-year increase from \$1.37 per household per month to \$2.39 per household per month to reflect the enhanced service. The average cost for recycling services (\$1.97 per month) for all of FY 2009/10 was passed on to rate payers effective July 1, 2009, so the full effect of the \$2.39 per household per month payment to Recology Santa Clara has not been incorporated into current customer rates.

The overall proposed summary change to the "Basic Service" (one 32-gallon can/small cart garbage; Clean Green; Recycling; Annual Clean-Up Campaign; and Household Hazardous Waste charges) is +\$2.70 (+12.2%) per month per residence. This includes +\$0.51 per month for garbage collection/disposal, +\$0.98 per month for Clean Green collection/composting, +\$1.16 per month for residential recycling, +\$0.05 for household hazardous waste. No change is proposed for the Clean-Up Campaign charge (\$3.80 per month).

It is proposed to increase the monthly garbage service component of the solid waste rates by 5.5% for single-family 1-can, 2-can, 3-can, front-load bin, and drop body debris bin services. No increase is proposed for extra bag tags. The proposed increase for 20-gallon Supersaver Cart service garbage component is +\$0.21 (+5.5%), which raises it to \$4.11 per month. The 20-gallon Supersaver Cart customers are subject to the same proposed rate increases to the Clean Green, residential recycling, and household hazardous waste collection components of the solid waste rates listed in the paragraph above.

The full slate of proposed customer rate increases for all levels of service are presented in Table A of the Resolution. Santa Clara's total charges for residential and commercial solid waste services will remain among the lowest and much less than the average in Santa Clara County. Table I and Table II detail rate comparisons (both current and proposed rates) among other jurisdictions throughout the County for specific container sizes.

#### ADVANTAGES AND DISADVANTAGES OF ISSUE:

Rate increases are necessary to pay for increases to garbage, Clean Green, and recycling, collection and disposal/processing, which are contractually required under the agreements with MTWS, Recology Santa Clara, and IDC/Newby Island Landfill. One of the City's budget principles is to increase certain fees that reduce subsidy from the General Fund while maintaining the City's low fee structure.

#### **ECONOMIC/FISCAL IMPACT:**

There will be an increased total charge of \$2.70 per month for single-can (32-gallon capacity)/Small Cart residential service, which includes increases of \$0.51 for garbage services, \$0.98 for Clean Green services, \$1.16 for recycling services, and \$0.05 for hazardous waste services. Rates for commercial front-load dumpster and drop body debris bin garbage services will be raised 5.5%. No increase is proposed for the Clean-Up Campaign.

#### DISCUSSION

# A. GARBAGE COLLECTION AND DISPOSAL: 5.5% INCREASE ON MOST RESIDENTIAL AND COMMERCIAL GARBAGE SERVICE LEVELS

The negotiated increases for garbage collection (paid to Mission Trail Waste Systems) and estimated adjustment formulae for garbage disposal (paid to IDC/BFI/Newby Island Landfill) combine to increase garbage rates for most residential and all commercial garbage service levels by 5.5%. Effective July 1, 2010, MTWS' Schedule of Tariffs will be increased by 2.0% on all types of service (residential cart/can service, front-load dumpster, and drop body debris bin). The Schedule of Tariffs will also be increased by 7.9% on January 1, 2011 if MTWS places a new CNG fuel residential side-load collection fleet into service.

The proposed increase in the garbage collection/disposal component of the solid waste rate takes into account that the full +9.9% shift in the Schedule of Tariffs is only occurring during the last six (6) months of the fiscal year. Staff does not intend to propose an additional increase to garbage rates mid fiscal year. The proposed +5.5% in garbage rates is designed to cover both the July 1, 2010 and January 1, 2011 shifts in the Schedule of Tariffs.

It should be noted that the recently amended franchise agreement (December 15, 2009) also provides an additional +9.9% shift in the Schedule of Tariffs, effective July 1, 2011. The garbage collection component of the solid waste rate will need to be shifted by a larger percentage than +9.9% in FY 2011/12 to keep pace with cost recovery because the FY 2010/11 proposed increases are not capturing the full effect of the shift in tariffs. The garbage disposal component adjustment formulae weights the San Francisco-Oakland-San Jose Consumer Price Index for 80% of its calculation. As a general rule of thumb, garbage collection costs are responsible for two-thirds, and disposal costs are responsible for one-third of the overall garbage component.

The garbage component of the solid waste rates for residential cart/can service will be \$9.76 per month for the 32-gallon cart (1-Can Service), \$19.21 per month for the 65-gallon cart (2-Can Service), and \$28.66 per month for the 96-gallon cart (3-Can Service). Customers with additional carts with continuous monthly service will be charged \$9.45 per 32-gallon container per month. Rates for front-load bin and drop body debris box services have been increased by 5.5%. The City of Santa Clara's rates for solid waste services will remain among the lowest, even if the proposed rate adjustments are approved by Council. See Tables I and II for a comparison of solid waste rates for different collection services in Santa Clara County.

The garbage component of the 20-gallon Supersaver cart rate is currently set at \$3.90 per month. Effective July 1, 2010, the City will pay MTWS \$4.60 per month to service 20-gallon Supersaver carts. It is estimated that the disposal component will be an additional \$2.30 per month, which brings the total cost of providing garbage service to 20-gallon Supersaver cart customers to \$6.90 per month. The garbage component of the 20-gallon Supersaver cart rate is proposed to increase by +5.5% to \$4.11 per month (+\$0.21) effective July 1, 2010. It is proposed to charge customers \$2.79/month less than 20-gallon Supersaver cart service costs in order to provide residents with the economic incentive to produce less garbage and utilize the landfill diversion programs offered by the City. Customers with the 20-gallon Supersaver cart service do pay the full cost of the Clean Green, residential recycling, household hazardous waste, and Clean-Up Campaign programs. 1,190 customers currently subscribe to the 20-gallon Supersaver cart.

Effective July 1, 2010, residents qualifying for Low Income Rate Discount will be eligible to receive \$1.25 per month discount off of their monthly garbage service. The current Low Income Rate Discount is \$0.90 per month. 26 customers currently receive the Low Income Rate Discount on garbage services.

#### B. CLEAN GREEN PROGRAM CHARGE: INCREASE TO \$8.53 PER MONTH PER RESIDENCE

The current service charge associated with the residential "Clean Green" (unlimited yard waste) collection service is \$7.55 per month per single-family and multi-family residence. The budgeted cost for providing this service in FY 2010/11 is approximately \$8.53 per month. It is proposed that the monthly Clean Green charge be increased to \$8.53 (+\$0.98). This will eliminate the General Fund subsidy for the Clean Green program and bring it to full cost recovery.

The cost for the Clean Green program is based on the exclusive franchise agreement with Mission Trail Waste Systems, and long-term landfill processing and disposal agreement with IDC/BFI Newby Island Landfill. The amount paid to MTWS to collect Clean Green will increase by 2.0% on July 1, 2010, and by 7.9% on January 1, 2011, if the fleet of CNG fuel collection vehicles is in service.

# C. <u>RESIDENTIAL RECYCLING PROGRAM CHARGE: INCREASE TO \$2.36 PER RESIDENCE PER MONTH</u>

On September 22, 2008, Council approved a new agreement with the City's current recycling program collector, Recology Santa Clara, to implement a residential single-stream recycling program. The single-stream recycling program was implemented in November/December 2009. Effective in December 2009, the amount paid to Recology Santa Clara shifted from \$1.37 to \$2.39 per month. The average cost for recycling services (\$1.97 per month) for all of FY 2009/10 was passed on to rate payers effective July 1, 2009, so the full effect of the \$2.39 per household per month payment to Recology Santa Clara has not been incorporated in customer rates yet.

Recology Santa Clara will not be eligible for an adjustment to its collection tariff until July 1, 2011, per its agreement with the City. The rate adjustment formulae is based solely on the percentage change to the San Francisco-Oakland-San Jose Consumer Price Index over the calendar year.

The projected operating expenditures for FY 2010/11 for the Solid Waste Fund's Recycling Program are \$1,228,000. If the proposed monthly residential recycling charge of \$2.36 per month is approved, projected revenues for the recycling program will achieve full cost recovery.

Funding the recycling program has become more challenging. In FY 2009/10, the State reduced revenues for beverage container payment disbursements. In addition, the revenues received from the AB 939 implementation fee (\$1.50 per ton disposed – collected at landfills and directed back to cities in Santa Clara County to fund landfill diversion programs) are down 10%, due to declining tonnage at landfills. The combined effect is about \$45,000 in lost revenue to the City to fund the residential recycling program.

A full year of the City's new residential single-stream recycling program, plus the roll-out of single-stream recycling for commercial businesses as part of the amended exclusive franchise agreement with MTWS,

will divert significantly more materials from the landfill in FY 2010/11, and in future years. This will reduce the amount of AB 939 implementation fees coming into the City to fund recycling programs.

### D. ANNUAL CLEAN-UP-CAMPAIGN CHARGE: NO INCREASE - REMAIN AT \$3.80 PER RESIDENCE PER MONTH

In 1992, a uniform levy per month was charged to all residential users in the City to pay for the availability of the Clean-Up Campaign, but did allow exceptions for tenants of large apartment complexes (50 or more units) if the owner entered into an agreement with the City assuring that there would be no participation by their tenants in the Clean-Up Campaign. The current charge is \$3.80 per month per residence. Actual costs of providing the annual Clean-Up Campaign service equates to about a cost of \$3.80 per month per participating residence. The 2009 Clean-Up Campaign was fully funded by the monthly charge, although tonnage was down significantly, compared to historical averages. Staff projects that the 2010 Clean-Up Campaign met full cost recovery, although the final accounting for the project is not yet complete. If the rate is held flat at \$3.80 per month and set-out sizes increase closer to historical averages, staff projects the 2011 Clean-Up Campaign to fall \$20,000 short of full cost recovery. Any difference between the actual cost of Clean-Up Campaign and the amount charged is made up by the City's General Fund. No increase in charge is proposed.

### E. HOUSEHOLD HAZARDOUS WASTE (HHW) CHARGE: INCREASE TO \$0.30 PER RESIDENCE PER MONTH

It is proposed that the monthly HHW charge to residents be increased by \$0.05 to \$0.30 per month. The number of Santa Clara residents that utilize the Countywide Household Hazardous Waste Program (CoHHWP) has increased by more than 20% over the last five years. The City's participation in the CoHHWP is mostly funded by a \$2.60 per ton HHW charge that is included on each ton of garbage that is disposed of at landfills. As discussed in Section C above, disposal tonnage is down about 10%, so the HHW revenues collected at landfills are down. The increase of \$0.05 per month per residence charge should enable the City to achieve cost recovery for HHW related programs.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANTA CLARA AD-JUSTING THE OVERALL RATES TO BE CHARGED TO CUSTOMERS FOR COL-LECTION AND DISPOSAL OF GARBAGE, CLEAN GREEN, AND RECYCLING SERVICES, ANNUAL CLEAN-UP CAMPAIGN, AND HOUSEHOLD HAZARD-OUS WASTE CHARGES IN THE CITY OF SANTA CLARA."

The purpose of the public hearing is to provide City staff with an opportunity to present the City Council and the public with information and proposed increases to the current rates charged for the collection and disposal of Garbage, as well as collection services for Clean Green, Recycling and Household Hazardous Waste. No changes are being proposed to the charge for the Annual Clean-Up Campaign service. Increases for the monthly garbage collection charges are proposed to pay for contractual cost-of-living formulae increases to be paid for collection and disposal. Proposed monthly garbage collection increases are \$2.65 per month for one garbage can/Small Cart residential service (including increases of +\$0.51 for garbage collection/disposal; +\$0.98 for Clean Green services; +\$1.16 for recycling services), and an increase of \$0.51 per month for each additional 32-gallon garbage can service. The remainder of the garbage collection service rates are proposed to be increased 5.5%. It is proposed to increase the household hazardous waste charge by +\$0.05 per month for all residential customers. No change is proposed for the Annual Clean-Up Campaign charge.
